17 The Second Interim Fee Application of Forman Holt Eliades & Youngman  
18 LLC ("FHEY"), special counsel retained by Thomas A. Seaman ("Receiver"), the  
19 Court-appointed permanent receiver for Medical Capital Holdings, Inc., Medical

1           **ORDERED** that the Second Interim Fee Application of FHEY for the  
2 Receiver of the Receivership Entities is allowed and approved in the amount of  
3 \$75,140.00 in attorneys' fees and \$5,907.78 in costs for services performed and  
4 costs incurred during the Fee Application period from July 14, 2011, through  
5 September 12, 2013; and it is further

7           **ORDERED** that the Receiver is authorized to pay 100% of the allowed  
8 amount of FHEY's fees, which amount is \$75,140.00, and to pay 100% of the  
9 allowed amount of FHEY's costs, which amount is \$5,907.78, out of assets of the  
10 Receivership Estate.
