The Fee Application of Allen Matkins Leck Gamble Mallory & Natsis LLP,
Counsel to the Receiver ("Allen Matkins") came before the Court. Appearances
were as noted on the record.

The Court having received and read the Motion papers and the Fee
Application, including any supporting declarations and objections filed therein, and
being so advised in the matter and finding good cause, orders as follows:

IT IS ORDERED that the Fee Application of Allen Matkins is allowed and
approved in the amount of \$396,751.50 in attorneys' fees and \$7,968.19 in costs, for

1 services performed and costs incurred during the Twenty-Third Application Period
2 from May 1, 2015 through June 30, 2016.

3 **IT IS FURTHER ORDERED** that all of the fees incurred by Allen Matkins
4 throughout the course of the receivership, in the total amount of \$9,590,491.90, are
5 approved.

6 **IT IS FURTHER ORDERED** that Receiver is authorized to pay 100% of
7 Allen Matkins' fees and costs for the Twenty-Third Application Period, or
8 \$404,719.69, as well as 100% of the amounts withheld from Allen Matkins' twenty-
9 two interim fee applications, or \$1,817,465.00, for a total amount of \$2,222,184.60,
10 out of assets of the Receivership Estate.

11 **IT IS FURTHER ORDERED** that Receiver is authorized to reserve
12 \$5,000.00 to pay reasonable fees and costs incurred by Allen Matkins after June 30,
13 2016. Such fees and costs may be paid without further Order of the Court.
