IT IS ORDERED that the Fourth Interim Fee Application of Allen Matkins is allowed and approved in the amount of \$602,113.50 in attorneys' fees and

1 \$9,847.11 in costs for services performed and costs incurred during the Fourth
2 Application Period from August 1, 2010 through October 31, 2010. The Receiver is
3 authorized to pay \$67,855.50 from funds previously provided to the Receiver by
4 Mail.com Media Corporation, and 80% of the remaining allowed amount of Allen
5 Matkins' fees, which amount is \$427,406.40, and to pay 100% of the allowed
6 amount of Allen Matkins' costs, which amount is \$9,847.11, out of assets of the
7 Receivership Estate.
