28 The First Interim Fee Application of Shartsis Friese LLP (“Shartsis Friese”),  
conflicts counsel to Thomas Seaman (the “Receiver”), the court-appointed  
Permanent Receiver for Medical Capital Holdings, Medical Capital Corporation,  
Medical Provider Funding Corporation VI, and their subsidiaries and affiliates  
(collectively, the “Receivership Entities”) came before the Court. Appearances  
were noted on the record.

The Court having received and read the Motion papers and the Fee

1 Application, including any supporting declarations and objections filed therein, and  
2 being so advised in the matter and finding good cause, orders as follows:

3 **IT IS ORDERED** that the First Interim Fee Application of Shartsis Friese is  
4 allowed and approved in the amount of \$270,065.75 in attorneys' fees and  
5 \$11,036.93 in costs for the First Interim Period from March 1, 2010 through  
6 September 30, 2010. The Receiver is authorized to pay 80% of the allowed fees or  
7 \$216,052.60, and 100% of the allowed costs, or \$11,036.93, out of the assets of the  
8 Receivership Estate. The attorneys fees of Colorado local counsel, Sander  
9 Ingebretsen, in the amount of \$12,157.75 are approved and the Receiver is  
10 authorized to pay 100% of such sum to Sander Ingebretsen out of the assets of the  
11 Receivership Estate.
