**IT IS ORDERED** that the Third Interim Fee Application of Allen Matkins is allowed and approved in the amount of \$563,951.50 in attorneys' fees and

1 \$17,326.64 in costs for services performed and costs incurred during the Third  
2 Application Period from May 1, 2010 through July 31, 2010. The Receiver is  
3 authorized to pay \$38,558.50 from funds previously provided to the Receiver by  
4 Mail.com Media Corporation , and 80% of the remaining allowed amount of Allen  
5 Matkins' fees, which amount is \$420,314.40, and to pay 100% of the allowed  
6 amount of Allen Matkins' costs, which amount is \$17,326.64 , out of assets of the  
7 Receivership Estate.
