1 The Court having received and read the Motion papers and the Fee  
2 Application, including any supporting declarations and objections filed therein, and  
3 being so advised in the matter and finding good cause, orders as follows:

4 **IT IS ORDERED** that the Third Interim Fee Application of Shartsis Friese  
5 is allowed and approved in the amount of \$340,313.10 in attorneys' fees and  
6 \$13,665.42 in costs for the Third Interim Period from May 1, 2011 through  
7 December 31, 2011. Shartsis Friese is authorized to apply current rates for non-  
8 partner timekeepers, subject to a 10% discount, beginning in March 2012. The  
9 Receiver is authorized to pay 80% of the allowed fees or \$272,250.48, and 100% of  
10 the allowed costs, or \$13,665.42, out of the assets of the Receivership Estate.
