I am counsel for Thomas Seaman who was appointed Permanent Receiver ("Receiver") pursuant to the Order entered on August 17, 2009. I submit this declaration in support of Alle Matkins' Second Interim Fee Application, filed concurrently herewith. I am the			

attorney primarily responsible for the supervision of this matter. I have personally reviewed the billings in this case and, therefore, have personal knowledge of the facts stated in this Declaration, which I could and would testify to if called upon to do so.

- 2. Attached hereto as **Exhibit A** is a true and correct copy of the billing invoices generated by Allen Matkins regarding its representation of the Receiver from November 1, 2009 through April 30, 2010 ("Second Application Period").
- 3. As to the work it performed during the Second Application Period, Allen Matkins has written off and written down fees and costs as appropriate to provide the best value to the receivership estate. By the Second Interim Fee Application, Allen Matkins seeks approval of \$1,303,884.50 in fees and requests that the Receiver be authorized to pay 80% of the requested fees, or \$1,043,107.60 at this time, as to which \$25,000 in fees should be paid using funds provided to the Receiver by Mail.com.
- 4. Allen Matkins also seeks reimbursement of \$32,620.33 in costs incurred during the Second Application Period.
- 5. With respect to the fees incurred for work involving the various Medical Provider Funding Corporations ("MP"), to the extent tasks impacted multiple MP entities or their assets, attorney time was split evenly between such entities.
